INTER-AMERICAN CONVENTION FOR THE PROTECTION AND CONSERVATION OF SEA TURTLES (IAC)



IAC Secretariat co-organized with the Government of France Side Event about best practices to mitigate bycatch of sea turtles in fisheries at CMS-COP14.

- The Secretariat of the Inter-American Convention for the Protection and Conservation of Sea Turtles, together with the Government of France/ French Biodiversity Agency (FBA), co-organized the Side event titled: "Experiences and collaborations in the application of best practices to mitigate bycatch of sea turtles in fisheries".
- The event took place on February 14th at the Expo Center in the city of Samarkand, Uzbekistan. The Focus was to present global practices to mitigate sea turtle bycatch in fisheries. The event also provided information on the implementation of CMS Decisions 13.61-13.63 ("Bycatch") and on the IAC Resolution, CIT-COP10-2022-R7 ("Reducing the adverse effects of fisheries on sea turtles").

- MSc. Verónica Cáceres, IAC Secretary, was the moderator of the panel that included 5 guest speakers who shared their experiences with the fishing sector as community leaders, NGOs and scientists presenting successful examples of mitigation methods developed with the collaboration of fishermen to reduce sea turtle bycatch.
- During the event, the video prepared by the Laud OPO Network was shared, recognizing the efforts of Laud OPO Heroes Program for the conservation of sea turtles by community leaders and artisanal fishermen from countries such as Mexico, Peru and Colombia (link to the video at: https://www.youtube.com/watch?v=YK2dW_7-e-s
- The panel included the participation of: Ms. Delphine Blanchar, Project Officer, from the National Museum of Natural History of France topic: Initiatives taken by France to preserve sea turtles and mitigate their capture. Mr. Hortensio Lima, Regional Manager of the Sea Turtle Survival Project topic: Minimize the bycatch of Sea Turtles in industrial fishing in West Africa, Ms. Melania-Lopez, Coordinator of ProPeninsula and member of WIDECAST, spoke about the projects developed in Mexico; Ms. Cecilia Fischer, WWF Wildlife Law Enforcement and Prosecution Officer, Coral Triangle Programme, presented the work they do to reduce bycatch in the French Guianas, protecting sea turtles through innovative initiatives and strong collaboration with fishermen local. -Mr. David Sarmiento-IMARPE -shared his experiences as a field observer in artisanal fisheries and as educator who works to build capacity for good management practices with fishermen in Peru.



The event called attention of CMS-COP14 participants to facilitate the adoption of Decisions on Bycatch and others fisheries induced mortality and the Decision on Sea Turtles.

Seventeenth Meeting of the Consultative Committee of Experts -CCE17

- On February 27 and 28, 2024, the 17th Meeting of the Consultative Committee of Experts (CCE) of the IAC was held (virtual format via Zoom). The meeting was attended by delegates from the 16 IAC Party Countries, and observers from the Governments of Canada, France, Trinidad and Tobago, as well as representatives of the SPAW Protocol and the CPPS.
- President of the CCE, Dr. José Eduardo Ponce G. presented to the plenary session the progress in the implementation of the CCE Work Plan − 2023, and the Work Plan for the period 2024-2025 was updated. The Scientific Committee (SC), through its Vice President Dr. Heriberto Santana, shared the recommendations during its SC20 meeting in October 2023.
- Among the collaborative activities between the IAC and Stetson University, Dr. Katherine Pratt presented the final document "Analysis of the IAC Annual Reports 2005-2023", a document whose objective is to highlight the progress in the implementation of the Resolutions of the IAC, according to the information shared by the Countries in their Annual Reports. The document will be presented at the IAC COP11 in June 2024.



- The members of the CCE made the following agreements: 1) Preparation of the Letter of Intent CIT-SPAW Protocol, 2) Formation of a Working Group to analyze the terms of reference of the Subsidiary Bodies of the CIT, 3) SC20 adopts the technical document CIT-CC20-2023-Tec.21 "Status of Loggerhead Turtles (Caretta caretta) within Nations of the IAC" updated 2014-2022 and CIT-CC20-2023-Tec.22 "IAC Index Beach Data Analysis 2009-2023", both documents will be presented at COP11 in 2024.
- The meeting was attended by 54 participants, whom we thank for their time, dedication and significant contributions to the success of the meeting. We take this opportunity to wish congratulations to Dr. Vicente Guzmán (CCE Delegate Mexico) who reported his official retirement. Words of gratitude were shared by the CIT Secretariat and the CCE President, recognizing his contributions to the CIT and dedication over many years. We will greatly miss his advice and support, and we hope that the ties of friendship will endure.
